Call for Concepts: Exploring Democracy, Environmental Justice, and Social Justice

Grantmaking area Higher Learning

Date October 24, 2023

Through its Higher Learning grantmaking area, Mellon invites humanities-grounded ideas for research and curricular projects focused on any of three topics.

Cultures of US Democracy

Projects that consider the circumstantial conditions that enable US democratic practices to flourish, including how those can best be achieved, nurtured, and sustained within an increasingly complex and fractured society.

Environmental Justice Studies

Projects that focus on specific systems (such as food, water, or health), ones that engage interrelated systems in a given community/locale, and ones that come at this topic through discrete analytical or disciplinary lenses.

Social Justice and Disciplinary Knowledge

Projects that best exemplify how specific disciplinary or interdisciplinary fields of study are equipped to reckon with issues of social justice, given the particular investigative and analytical methods they deploy.

• Humanities-grounded ideas for research or curricular projects focused on:

Cultures of U.S. Democracy Environmental Justice Studies Social Justice and Disciplinary Knowledge

- Grants of \$250,000-\$500,000 over a duration of up to three years
- U of M Duluth and Twin Cities campuses may each submit up to three applications
- IAS will coordinate U of M's internal review, selection, and endorsement process

Eligibility

Principal Investigator (PI)

- Tenure-track or tenured faculty member or dean in a program or department in the humanities or humanistic social sciences
- Based at the University of Minnesota Duluth or Twin Cities
- Architecture (historical or theoretical), Musicology, Performance Studies, and others at the U of M that
 might fall into a professional college, yet may incorporate humanities-based perspectives and
 methodologies, are included.

Not Eligible

Medical schools and centers and other health professions schools; engineering and other technology-related schools; business and management schools; arts, music, and design schools; law schools; and seminaries or seminary like institutions.

The IAS will select applications for submission to the Mellon Foundation and arrange for endorsement letters.

Step 3: Submit application to the Mellon Foundation

Deadline: Thursday, February 15, 2024 at 2:00 pm CST

Step 4: Submit proposal to the Mellon Foundation (if invited)

Deadline: October or November 2024

Finalists will be invited by the Mellon Foundation in Summer 2024 to develop proposals for submission to the December 2024 Mellon Board meeting.



Instructions for Step 1: Register with the Mellon Foundation for the 2024 Call for Concepts

You must register with the Mellon Foundation through their Fluxx portal system by 2 p.m. CDT on Thursday, November 30. If you do not register with the Mellon Foundation by this deadline, you will not be able to apply for this opportunity.

Information you will need for the registration form (responses marked in bold).

- You must choose which of the three topic areas your project falls under:
 - Cultures of US Democracy
 - Environmental Justice Studies
 - Social Justice and Disciplinary Knowledge
- Is the applicant institution a four-year, non-profit, accredited, degree-granting institution in the US that offers liberal arts education? YES

Step 2: Submit Concept to IAS

Deadline: Friday, January 12, 2024 at 11:59 pm CST → via InfoReady

- 1. Select one of the three topic areas: Cultures of U.S. Democracy, Environmental Justice Studies, or Social Justice and Disciplinary Knowledge
- 2. Description of your potential project, including the rationale and specific activities it might involve. Clearly state the necessity of the planned work, its goals, potential impact, and the fitness of the institution and/or network to the proposed work. (8,000 characters, including spaces, max)
- 3. Estimated budget total for your project. Provide a list of the types of expenses the grant would fund e.g., stipends, course releases, fellowships, workshops, etc. It is not necessary to provide estimates. (800 characters, including spaces, max)

A selection committee convened by the IAS will choose up to three concepts per eligible system campus (Duluth or Twin Cities) to be submitted to the Mellon Foundation.

Notification will be sent by February 1, 2024. The IAS will arrange for the required letters of endorsement from the Provost.



Step 2: Submit Concept to the IAS

Deadline: Friday, January 12, 2024 at 11:59 pm CST

- 1. Submissions should be made via InfoReady
- 2. Select one of the three topic areas: Cultures of U.S. Democracy, Environmental Justice Studies, or Social Justice and Disciplinary Knowledge
- Provide an approximately 1,000-word description of your potential project, including the rationale and specific activities it might involve. The note should clearly state the necessity of the planned work, its goals, potential impact, and the fitness of the institution and/or network to the proposed work. (8,000 characters, including spaces, max)
- 4. Enter an estimated budget total for your project. In the description field, provide a list of the types of expenses the grant would fund e.g., stipends, course releases, fellowships, workshops, etc. It is not necessary to provide estimates. (800 characters, including spaces, max)

A selection committee convened by the IAS will choose up to three concepts per eligible system campus (Duluth or Twin Cities) to be submitted to the Mellon Foundation. Notification will be sent by February 1, 2024. **The IAS will arrange for the required letters of endorsement from the Provost.**

Step 3: Submit Application to Mellon

Deadline: February 15, 2024 at 2:00 p.m. CST

- 1. As necessary, revise your concept statement and draft budget justification.
- 2. Develop a Diversity, Equity, and Inclusion statement (approximately 250 words, no more than 2,000 characters, including spaces). Applicant institutions should have a demonstrated track record of successfully pursuing DEI efforts on their campuses. Provide a brief paragraph outlining those efforts. Optionally, you may also provide a website link.
- 3. Develop a Humanities statement (approximately 250 words, or no more than 2,000 characters, including spaces). Applicant institutions should have a demonstrated track record of excellence in the humanities. Provide a brief paragraph outlining those efforts. Optionally, you may also provide a website link.
- 4. Finalize application statement, complete application form, and submit application through the Mellon Foundation's Fluxx portal by February 15, 2024 at 2:00 p.m. CT.

The Institute for Advanced Study is available to support:
